Figure 4-1 of the *Practice Standard for Work Breakdown Structures* (Page 23) shows an annotated version of the WBS for a bicycle. It identifies elements 1.4 (Braking System) and 1.5 (Shifting System) as needing more decomposition. Your assignment is to add detail to this WBS as follows:

- 1. Add at least three level 3 elements to the braking system (i.e. 1.4.1, 1.4.2, and 1.4.3)
- 2. Add at least three level 3 elements to the shifting system
- **3.** Add a new section, **1.8**, for the element "Smart Phone Speaker Dock." Make sure it has at least three level 3 elements as well.
- 4. Use any one of the WBS formats described in Appendix D of the Practice Standard for Work Breakdown Structures, including:
 - 1. D.2 Outline View
 - 2. D.3 Tabular View
 - 3. D.4 Tree Structure View
 - 4. D.5 Outline View with Dictionary Elements
- 5. You must submit the complete WBS for this assignment, not just the changes you make.
